7. What is your interpretation of the Tenth Amendment of the United States Constitution and how it relates to states' rights? Give specific examples relating to Alaska.

I don't know how to word it any clearer than how it is worded in the Constitution.

"The powers not delegated to the United States by the Constitution, nor prohibited by it to the states, are reserved to the states respectively, or to the people."

Simply put the Federal Government has a list of certain powers and responsibilities and anything else is reserved to the States unless otherwise prohibited.

The list of violations to the 10th Amendment by the federal government would fill a book. An example here in Alaska is the Federal Government's involvement with State issues on State land like with the EPA sticking its nose into the Pebble Mine process or the Federal Park Service arresting people on State waterways.

8. Name four things Alaska can and should do to reduce health care costs.

Competition! Competition! Competition! Competition! This means a reduced roll for government while at the same time passing laws that encourage competition on all levels. We need to get rid of things that squash competition. We need competition among doctors of the same and different medical disciplines; we need competition across state lines among medical insurance companies. We need to do away with the certificate of need that protects hospitals from competition. Its real simple - increased competition means lower prices and better service.

9. Do you support the current processes for Alaska judicial appointments and retentions? Why or why not?

No, I believe the Judicial Council is unnecessary and that the governor should be able to appoint Judges directly with the approval of the legislature.
